- 4. Technical Advisory Committee Report Commissioner Rick Robles
 - Commissioner Robles reported on the TAC meeting of June 15, 2015, highlighting that Committee Member Jan Hefner, Executive Director, Community Health Initiative, would be retiring and consequently leaving the TAC, and that Marc Thibault, Consultant, lead the TAC on a discussion of Strategic Planning next steps.

 - Ms. St Pierre reported that First 5 California launched a new statewide media campaign that encourages parents and caregivers to talk, read and sing with children 0 to 5 to encourage early brain development.
 - Ms. St Pierre reported that July 8, 2015, staff attended the Kaitlyn's Law press conference and safety demonstration and stated that 11 children have perished this year due to being left alone in hot cars.
 - Ms. St Pierre reported that staff had a booth at the 2015 Kids Fest, held at Pioneer Village, which was well attended.
 - Ms. St Pierre reported that August 6, 2015, is the Back to School Fair sponsored by Kern County Child Support Services, to be held at the Kern County Fairgrounds.

 - Marc Thibault reported that the Medically Vulnerable Care Coordination Project (MVCCP) has been recognized by the Association of Maternal & Child Health Programs as a promising practice.
 - Mr. Maier gave a Persimmony update, reporting that the second data transfer will be completed soon and that the switch from Mosaic, Inc., to Persimmony will begin next week; training for the programs' administrative staff is complete and the training for programs' fiscal staff will be held in September 2015.
