- ✓ The Committee felt that this is a question that each program would
 have to answer individually but would need to document return on
 investment; link to key stakeholders like County service systems,
 school districts and medical provider networks; Summer Bridge
 Programs being absorbed into some local school districts; Dignity
 Health's Community Wellness Program partnership with Kern
 Health Systems focused on developing Certified Diabetes
 Educators; and My Path to Good Health booklet as a model for
 other initiatives.
- What Do We Need To Do To Assess The Local, State and National Landscape For Our Services, Now And Over The Next Five Years?
 - ✓ Responses from the Committee were to work with the Department of Human Services to enter a model for CCS; a need for community based organizations to be a part of integration, for example the Affordable Care Act and CCS dollars. Invite a representative from Representative Kevin McCarthy's office to present at our next meeting September 21, 2015, to present information on the latest federal initiatives re: child care (CCDBG); parenting; child health; school readiness and family economic security.
- What Is The Likeliness For Sustainability?
 - ✓ Maintaining the same approach requires engaging with parents in getting their opinions, telling their experiences, and sharing their results on their children/families from services received; and to help parents become active in advocating for themselves and their neighbors in supporting the need for local services that are culturally sensitive, relevant and useful.
- What do we need to know to sustain programs after 2020?
 - ✓ The Committee agreed that utilizing My Path To Good Health and presenting Joyce Epstein's Model of Parental Involvement on September 21, 2015.
